Procedure for Maintaining a Domain Name When It Is Not Serviced by the Registrar

- 1. In the event that a contract between the public domain Administrator and the Registrar is subject to termination, the Registrar shall facilitate the transfer of respective domain names for servicing to other registrars. The domain names that have not been transferred for servicing to other registrars as of the termination date of the aforementioned contract shall be deposited for temporary storage in the Registry in order to ensure their uninterrupted operation. At the same time, the entry on the Registrar in the WHOIS service (the *organization* and the *organization-loc* fields) shall read: *No Registrar*. *Domain To Be Transferred to Registrar*. The domain name shall remain as it was when accepted in the Registry from the Registrar on the contract termination day and shall not be subject to any alterations while temporarily stored in the Registry.
- 2. Registration data regarding the domain name that is temporarily stored in the Registry cannot be altered. Such option will become available only after the domain name has been transferred for servicing to a new registrar. Domain name transfer to a new registrar shall be carried out pursuant to the corresponding procedure for transferring a domain name to a new registrar. A new registrar can be selected from the list that can be found at https://hostmaster.ua/registrars/.
- 3. Contact information on natural persons acting as registrants, whose domain names are temporarily stored in the Registry, may not be posted in the WHOIS service, regardless of whether or not such information was open with the previous registrar (before the domain name has been deposited for temporary storage in the Registry). The aforementioned contact information shall become open for posting in the WHOIS service only after the domain name has been transferred to a registrar and subject to sending a corresponding request to such registrar.
- 4. A registrant and other contacts of a domain name can verify the accuracy of their registration data at the following link <u>https://hostmaster.ua/contact_info.php</u>. The necessary access details will be sent to the contact e-mail address as indicated in the domain name upon the corresponding request addressed to the Registry Support Service at <u>help@uanic.ua</u>.
- 5. In the event that a domain name has not been transferred to a new registrar, such domain name shall be automatically deleted from the Registry upon the expiration of the registration term in accordance with the Public Domain Policy. The registration term is indicated in the *expired* field of the domain object in the WHOIS service. Pre-term deletion of a domain name or extension of a domain name registration may be done only subject to transfer for servicing to a new registrar.
- 6. Where a natural person is acting as a registrant that is unwilling to transfer the domain name for servicing to a new registrar and thus chooses to keep the domain name in temporary storage in the Registry until its registration has expired, such registrant shall give consent to processing of its personal data by the Domain Name Administrator, which can be done at: https://hostmaster.ua/contact_info.php. By failing to transfer the domain name to a new registrar and leaving it in temporary storage in the Registry, the registrant gives its consent to subsequent processing of its personal data by Hostmaster LLC in order to ensure uninterrupted operation of the domain name until such time that its registration has expired and it has been deleted from the Registry.
